

MINUTES – April 15, 2013

The Mental Health & Recovery Board of Clark, Greene and Madison Counties met on Monday, April 15, 2013 at 6:00 p.m. at the Clark State Community College, Library Resource Center, Room 209, 570 East Leffel Lane, Springfield, Ohio.

OPENING REMARKS

Roger Roberts, Chairperson, called the meeting to order and welcomed the Board membership and guests to the meeting. Roger called on Board members and the audience to introduce themselves. Roger stated that there was an amended agenda distributed; this is attributed to the omission of Greene County Family and Children First from the original agenda.

APPROVAL OF MINUTES

The Board Minutes for March 18, 2013 Mental Health & Recovery Board meeting were reviewed. Scott Anger requested that his name be added to the Board members present at the March 18th meeting. Roger asked for a motion as amended.

IT was MOVED BY JIM VERNON, SECONDED BY KIM MICHAEL TO APPROVE THE MINUTES FOR THE MARCH 18, 2013 BOARD MEETING AS AMENDED.

REVIEW OF VOUCHERS

Voucher lists dated March 15, 2013, March 22, 2013, March 29, 2013 and April 5, 2013 were reviewed. There were no comments.

CEO REPORT

Kent informed the membership that Alexia Callahan has resigned from the Board due to health issues. He stated that in the proposed state budget there is a provision that allows mental health boards to decide whether they want 14 or 18 Board members. Kent suggested to not recruit a new Board member until action is taken by the state on this new provision.

Next, Kent provided a budget update. The Governor's budget did not increase allocations to Boards, but did expand Medicaid. The House did include new funding, but removed Medicaid expansion. The Senate has not approved a budget. Kent met with Senator Chris Widener, who does not support Medicaid Expansion, but is interested in expanding the current Medicaid program to cover more people. Kent also stated that he spoke to Representative Ross McGregor who does support Medicaid Expansion and stated that his office is receiving phone calls of approximately 2 to 1 in favor of Medicaid Expansion. The final budget will likely not be approved until the end of June.

Kent then stated that CEO evaluation forms were distributed to Board members at tonight's meeting and have also been distributed to Board staff. He asked that the evaluations be completed and returned to the Board office by May 17th. The results will be presented at the June Board meeting.

Lastly, Kent reminded the membership that there will be an awards ceremony prior to the June 17, 2013 Board meeting from 6:00 p.m. to 6:50 p.m. with the Board meeting beginning at 7:00 p.m. The location of both events is Clark State Community College, Library Resource Center.

NOMINATING COMMITTEE

Roger Roberts stated that the members of the Nominating Committee are Scott Anger, Julie Anthony, Delvin Harshaw, Lauren Ross, Jim Vernon and himself. This Committee met prior to tonight's Board meeting. Board members eligible for Chair for fiscal year 2014 are Julie Anthony, Delvin Harshaw, Jim Hutchins, Lauren Ross and Jim Vernon. The committee nominated Jim Vernon for Chair. Board members eligible for Vice-Chair are Julie Anthony, Linda Griffith, Delvin Harshaw, Ben Harrison, Jim Hutchins, Kim Micheal, Roger Roberts and Lauren Ross. Lauren Ross was nominated for Vice-Chair. Board members eligible for Secretary are Julie Anthony, Linda Griffith, Ben Harrison, Jim Hutchins, Kim Michael, Roger Roberts, Lauren Ross and Jim Vernon. The committee nominated Julie Anthony for Secretary. Roger stated the Board's By-Laws define how long an individual must be a member of the Board before he or she is eligible to be nominated for these positions and that the Chair and Vice-Chair must be from different counties. In May the Board membership will accept nominations from the floor and vote on the fiscal year 2014 officers.

<u>ADMINISTRATIVE</u>

Roger called on Kevin Taylor to review the Mental Health & Recovery Board financials. Kevin referred the membership to Attachment C in the agenda packet reviewing the Statement of Cash Position and Fund Balances as of March 31, 2013. This report is strictly on a cash basis with total cash receipts of \$17,211,259 and total cash disbursements of \$14,841,032 with an ending fund balance of \$11,826,014.

The next report represents the Statement of Receipts and Disbursements for the General Fund with receipts of \$10,539,103 and disbursements totaling \$7,549,057 and an ending fund balance as of March 31, 2013 of \$2,985,619.

The third report represents the Statement of Receipts and Disbursements for the Special Revenue Funds. Year-to-date as of March 31, 2013 receipts total \$2,622,371; disbursements total \$2,348 762, with receipts over disbursements by \$403,608.

The last financial report represents the Statement of Receipts and Disbursements for the Fiduciary Funds as of March 31, 2013. Total receipts are \$1,783,339; total disbursements are \$1,084,329, with receipts over disbursements of \$699,010.

Kevin then reviewed the 3nd quarter Budget to Actual – Administration and Support Summary for fiscal year 2013. Total actual expenses were \$778,566, with total budgeted expenses of \$855,188, reflecting actual expenses under budget by \$76,623.

Lastly, Kevin reviewed the Board's Projected Cash Position. The actual ending cash balance as of March 31, 2013 was \$11,110,678. Board staff anticipates a cash balance as of January 2014 of \$5,266,884.

AD HOC MINI GRANT COMMITTEE

Roger gave the report of the Ad Hoc Mini Grant Committee meeting held Friday, April 5, 2013 at the Mental Health & Recovery Board Administrative offices in Springfield. Roger stated that the Committee reviewed the Mini Grant process and received updates on the FY 2013 Mini Grant projects and discussed the process for FY 2014. A Committee summary was distributed before the meeting.

MENTAL HEALTH AND ALCOHOL/DRUG

Roger called on Jim Vernon, Acting Committee Chair to give the report of the Combined Mental Health and Alcohol/Drug Committees meeting held Tuesday, April 2, 2013 at the Greene County Educational Service Center. Jim referred the membership to Attachment D in the Board packet and reviewed the report. Jim read the first motion for FY 2014 Agency Allocations.
